Purpose	To provide a safe and secure learning and teaching environment for students and staff by establishing processes to monitor and manage visitors to Berwick Fields Primary School.
Scope	This policy applies to any visitors who may attend school grounds when the school is open for instruction between the hours of 8:30am to 4:00pm, and when the office is staffed to monitor/receive visitors at reception from 8:15am to 4:00pm, and when the office is staffed to monitor/receive visitors at reception, including parents, contractors, and other visitors. Outside of these times, our front office is not staffed and this policy does not apply.
Definitions	Child-related work: As defined by the Worker Screening Act 2020 (Vic), child-related work is work that usually involves direct contact (including in person, over the phone, written and online communication) with a child that is a central part of that person's duties. It does not include work that involves occasional direct contact with children that is incidental to the work.
Implementation	Berwick Fields Primary School strives to create an open and inclusive school community, and encourages parents and carers to be actively involved in their child's development and education. We also strive to foster strong partnerships with local community services, schools and other organisations.
	Berwick Fields Primary School is not a public place. The principal has the authority to permit or deny entry to school grounds, and encourages all visitors to familiarise themselves with our school's Statement of Values, Child Safe Policy, Statement of Commitment to Child Safety, Child Safe Code of Conduct, Volunteers Policy.
	From time to time, different members of the public may visit our school. Visitors may include, but are not limited to:

- Persons authorised to enter school premises (e.g. Worksafe inspectors, health officers etc)
- Other Department of Education and Training staff (including allied health staff) or contractors
- NDIS therapists or other allied health or health practitioners

## Sign in procedure

All visitors to Berwick Fields Primary School are required to report to the school office on arrival (see exceptions below in relation to parents/carers). Visitors must:

- Sign in on the iPad and record their Lanyard Number, First Name, Last Name, Reason for visit, Tick Covid19 boxes, Signature, Working with Children's Name (when required), WWCC Number (when required)
- Provide proof of identification to office staff upon request
- Produce evidence of their valid Working with Children Clearance where required by this policy (see below)
- Wear a visitor's lanyard at all times
- Follow instruction from school staff and abide by all relevant school policies relating to appropriate conduct on school grounds including: Child Safety Code of Conduct, Child Safe, Statement of Values and School Philosophy as well as Department policies such as the <u>Sexual Harassment Policy</u> and <u>Workplace Bullying Policy</u>
- Return to the office upon departure, sign out and return visitor's lanyard

Berwick Fields Primary School will ensure that our school's Child Safety Code of Conduct are available and visible to visitors when they sign in.

#### **COVID-19 vaccination information**

Our school follows Department of Education and Training policy with respect to the requirements relating to attendance on school site and COVID-19 vaccinations.

## **Working with Children Clearance**

For Working with Children (WWC) Check and other suitability check requirements relating to parents/carers and other volunteers working with students please see our Volunteers Policy

All visitors who are engaged in child-related work (see definition above) must have a valid WWC Clearance.

In some circumstances, visitors to Berwick Fields Primary School who are not engaged in child-related work will also be required to produce a valid WWC Clearance depending on the particular circumstances of their visit. For example, Berwick Fields Primary School will require a valid WWC Clearance for:

- visitors who will be working regularly with children during the time they are visiting, even though direct contact with children is not a central part of their normal duties
- visitors (e.g. contractors), who will regularly be performing unsupervised work at the school during school hours or any other time where children are present. Further background checks, including references, may also be requested at the discretion of the principal.

Visitors who will be working in areas away from students (e.g. a visiting auditor who will be located in the front office with administration staff) or who will be supervised and accompanied

by a staff member during their visit (e.g. a Member of Parliament, a journalist, a prospective parent on a school tour) will not be required to have a WWC Clearance. Sworn Victoria Police officers or sworn Australian Federal Police officers are exempt from requiring a WWC Check, but may be asked to verify that they are sworn officers by providing proof of identification.

## Invited speakers and presenters

On occasion, Berwick Fields Primary School may invite external speakers or providers to deliver incursions, presentations, workshops and special programs for our students. Consistent with Department of Education and Training requirements, Berwick Fields Primary School will:

- ensure that the content of presentations and programs by external providers contributes to the educational development of our students and is consistent with curriculum objectives
- ensure that any proposed visit, programs or content delivered by visitors complies with the
  requirement that education in Victorian government schools is secular [(apart from the
  provision of Special Religious Instruction) delete this if your school does not offer SRI]
  and is consistent with the values of public education, Department policies and the
  Education and Training Reform Act 2006 (Vic). In particular, programs delivered by visitors
  are to be delivered in a manner that supports and promotes the principles and practice of
  Australian democracy including a commitment to:
  - elected government
  - o the rule of law
  - equal rights for all before the law
  - freedom of religion, speech and association
  - o the values of openness and tolerance
  - respect for the range of views held by students and their families.

### **Parent visitors**

We understand that there may occasionally be a reason why a parent or carer may want to speak to or see their child at school, during school hours.

If there is a particular pressing or unavoidable issue that cannot wait until the end of the school day, we ask that parents or carers call the school office to make the request to speak to or see their child during school hours.

We also ask that parents avoid arranging to visit their children at school wherever possible, as this can cause inappropriate disruptions to the school day.

All parents or carers who visit our school during school hours, other than for the purposes of school pick ups and drop offs or for specific school events (eg parent teacher interviews, concerts, assemblies etc), are required to sign in as a visitor at the school office.

Parents or carers who are prohibited from entering the school under a court order or direction of the Principal are not permitted to visit the school.
